The Position

Under the general supervision of the Recreation Supervisor, or Team Leader provides instruction and control over youth designated sport, game, competition, includes working solo. Prepare facility for game play. Directs the start, duration, and conclusion of scheduled games. Enforces established rules as set forth by the District. Submits game results to the District.



Essential Functions:

- Impartially presides over competitive game play in a designated sport, with or without partner
- Enforces rules as set forth by the District, explaining infractions or rule violations to participants in order to understand the error and avoid further infractions
- Ensures safe play and a safe play environment for all participants, (walks the fields/gym and removes or cleans away any hazards)
- Maintains control of the game, game participants, coaches, managers and spectators
- Reports hazards, vandalism, incidents and accidents to the Recreation Supervisor immediately and submits proper reports as required
- Officiates in a quality, consistent and impartial manner at all times
- Submits game results to the Recreation Supervisor immediately following the games
- Informs Recreation Supervisor of Participant Complaints, concerns, faulty or poor equipment or other pertinent information as it pertains to the league

- Informs Recreation Supervisor of Participant Complaints, concerns, faulty or poor equipment or other pertinent information as it pertains to the league
- Must be of sound mind, and good moral character
- Must be responsible and enjoy working with children
- May be required to clean bodily fluids
- Provides team managers or coaches with information as directed
- Must work cooperatively with public, fellow employees and facility operator
- Other duties as may be required

Knowledge of:

- Complete knowledge of specific sport rules governing play
- Education and experience in recreation, physical education or athletics is desirable

Ability to:

- Prepare reports, present recommendations to Recreation Supervisor
- Communicate effectively, both verbally and written (in English)
- Work harmoniously with fellow employees; the public and other agencies
- Work under stressful and sometimes difficult circumstances
- Able to make quick decisions
- Must be able to maintain a professional attitude at all times
- Must be a team player
